

Thus information on various Research and technological advancements should be disseminated to the users of technology in order for our country to develop faster. Thus a culture to make aware of development of research and technology to pertinent users is essential. This has become more pronounced in the globalised economy with international agreements and obligations in the fields of IPR in the WTO regime. Huge information is to be provided while filing a patent application in order to ensure full disclosure of the invention. Thus, the patent information provides the large single source of technical information in the world today. However, access to this information and other facilities related to IPR are really inadequately available in the academic and other institutions in India.



As a first step in this direction to provide patent related services particularly to the S&T community, Intellectual Property Rights Management Cell (IPRMC) started functioning at Integral University, Lucknow under guidance and help of Council for Science and Technology, Government of Uttar Pradesh in January 2014. The cell comes under the Integral Information and Research Centre (IIRC), started functioning as a service centre to render IPR related services among S&T community.

IPRMC intends to provide information, orientation and facilities to scientists and research fellows/scholar of Integral University and its collaborating institutions/universities for protecting the products of their intellectual powers. The Cell would also be able to guide and advise researchers on how to obtain and sustain patents, facilitate routing of patent searches to Patent Information Centre (PIC) and getting the necessary clearances from the competent authorities in the university while filing provisional/complete patent specifications. This Cell would also workout various modalities on behalf of the University for Technology transfer/commercialization of patented technologies.

ABOUT UPCAR

The UPCAR is an autonomous apex state organisation registered as a society, which plans, co-ordinates and promotes research, education, training and transfer of technology for advancement of agriculture and allied sciences.

The UPCAR was established on June 14,1989 with its headquarters at Lucknow.
