The students learned how the machines are manufacturing the products in different levels from raw materials to the final products. There were various automated and very few manual machines. #### **Other Projects Undertaken by SIIDCUL:**

**Plastic Park-** SIIDCUL has been developing a Plastic Park under the Government of India's Department of Chemicals and Petrochemicals' scheme of "setting up of plastic

parks in India". SIIDCUL has identified 40 acres of land in IIE Sitarganj Phase-II under the project. The State-of-the art Plastic Park will have a Plastic Recycling Facility, a CIPET Centre, Plastic Product Evaluation Centre (PPEC), Tool room, CFC etc. SIIDCUL has already allotted 17 plots to interested investors and 48 plots are vacant at present.

**Aroma Park-** SIIDCUL has developed an Aroma Park at IIE Kashipur under the Aroma Park Policy 2018 of the Government of Uttarakhand. 24 nos. of Industrial plots have been allotted to investors and 23 plots are lying vacant. Aroma Park will reap benefits from the presence of GB Pant University of Agriculture & Technology, Centre for Aromatic Plants, Forest Research Institute etc. The Aroma Park has been developed to promote niche sectors like Herbs & Aromatics where the state has advantages of adequate availability of aromatic produce and suitable agro-geo climate for aromatics cultivation. Skilled manpower and R&D capabilities are available within the state.

**Electronics Manufacturing Cluster-** SIIDCUL has been developing an EMC at IIE Kashipur in around 133 acres of land under of Ministry of Electronics and Information Technology (MeITY)'s scheme EMC 2.0. The EMC at IIE Kashipur will have the following facilities: Plug & Play Facility, Ready Built Factories (RBF) sheds, Warehousing facility, Employee Hostel, Fire Station, Medical Facility, Business Complex etc. The broader aim is to support the existing ESDM ecosystem and to attract global Electronics manufacturers with their supply chains to the State.

**AKIC-** SIIDCUL has identified and earmarked 1002 acres of land in Khurpia, TehsilKichha, District Udham Singh Nagar for the development of an Integrated Manufacturing Cluster under the Government of India's ambitious Amritsar Kolkata Industrial Corridor project. An SPV has been formed NUITL (NICDC Uttarakhand Industrial Township Ltd.) for the implementation of the project. In terms of common infrastructure, the IMC will have STP, CETP, Daycare facility, Skill Development Center, Hospital, Dedicated Power Substation, Truck Terminal, Workers Canteen, Community Area, Shopping Center etc.

**Chharba-** With a nation-wide emphasis on strengthening healthcare systems, the pharmaceutical sector (Bulk Drugs, APIs, PPEs, Medical Devices etc.) is expected to grow significantly and will require huge investments. Considering this aspect, Government of Uttarakhand has proposed to attract pharmaceutical industries to Chharba, Dehradun. It will also be developed as a key Knowledge Hubs of the State.
