Intellectual Property Rights Management Policy

Establishment of Patent Cell:

The Patent cell will assist the University to manage its intellectual property (IP), provide services for IP patenting, copyright and licensing to all Schools/Centers of the University. The Cell will assist the University to file patent applications in India/abroad and execute other documents viz. execute license, and material transfer agreements; enter into confidentiality and non-disclosure agreements. The cell will also assist the investigators on technology mapping/ technology scanning of important projects being undertaken. Financial Support to establish IPM cell would initially be provided out of the University funds. Additionally, the patent filing costs could be met from any of the following sources:

- (i) Patent Cell's resources
- (ii) Paid by the inventor through project grants,
- (iii) Through external agencies like NRDC, TIFAC, BCIL etc. Some of the funding agencies sanction grants only on the condition that the technology developed as a result of the project funded by them will belong to them. In that case the inventor has to follow the conditions laid down by the funding agency.

Objectives:

To facilitate faculty and researchers of the University for patent filing and searches, GI registration, Copyrights, Industrial design, Electronic circuit copyrights, New drugs, New Plant Varieties NPV, etc. Building up capacity of subject specific patent landscaping has been envisioned. The patent Cell will assist the University to file patent applications in India/abroad and execute other documents; execute license, and material transfer agreements; enter into confidentiality and non-disclosure agreements.

Benefit Sharing

Universities the world over have acknowledge the claims of academic creators to have some share in the income derived from the technology transfer. The revenue received as a result of patents in the form of cash royalties and/or equity shall be distributed in such a manner as to encourage technology development and its transfer.

Proposed Benefit Sharing - The benefits received by the University on account of technology transfer in a year shall be shared between the Inventor/inventor's team as per University rules & regulations in the following manner.

S.No	Terms	Share
(i)	Money received upto 30% of the gross salary of individuals (Basic + DA)	No Sharing (with the University)
(ii)	Money received beyond 30% and upto the gross salary	80:20 between the inventor's team and the University
(iii)	Money received beyond gross salary	50:50 between the inventor's team and the University

Conflict of Interest and its Settlement

If an inventor has a grievance about the University's handling of intellectual property, he/she can take the benefit of the Grievance Redressal Mechanism already existed in the University.

Awareness and other activities

- 1. To disseminate knowledge on patents, patent regime in India and abroad and registration aspects
- 2. To impart training patent filing processes and organize seminars and presentations to expose participants to the basic concept of IPR and its strategic role in Indian context through interactions with experts.
- 3. To encourage faculty members and scholars to go for patentable works
- 4. To sign MoUs with National and International organizations for global visibility of Integral patents. For instance, National Research Development Corporation (NRDC), an autonomous unit of Department of Science and Technology, Ministry of Science and Technology, GOI facilitates commercialization of patents and provides the necessary platform.
