Drug development faces the double challenge of increasing costs and increasing pressure on pricing. To avoid that lack of perceived commercial perspective will leave existing medical needs unmet, pharmaceutical companies and many other stakeholders are discussing ways to improve the efficiency of drug research and development. Keeping in this view, the Faculty of Pharmacy organized a **Two Weeks Professional Development Program (PDP) on "Strategies to overcome challenges in Drug Development"**. The duration for the PDP was 9th November to 24th November. The sessions were held online on Google meet Platform. 


Valedictory Session
