

## Report : Visit at Lok Adalat, District Court Lucknow by Faculty of Law

The Legal Aid Society, Faculty of Law, Integral University organized a Lok Adalat Visit at District Court, Qaisarbagh, Lucknow under the direction of the District Legal Services Authority on March 12, 2022. Legal Aid Society Faculty Coordinator Mr. Ashraf Azmi and Mr. Wasim Ahmad were present along with students in the Lok Adalat.

The Legal Aid Society was established under the guidance of Dr. Abhishek Kumar Singh, Associate Professor, Integral University to promote the objectives of Article 39A of the Constitution of India. Legal Aid is a method that envisages the poor to have simple access to courts and other government organizations. Legal aid to the poor is fundamental for the protection of guidelines of law which is important for the presence of an orderly society

The Lok Adalats are formed to fulfil the promise given by the preamble of the Indian Constitution—securing, justice – social, economic, and political of every citizen of India. The idea of Lok-Adalat was mainly advocated by Justice P.N Bhagwati, a former Chief Justice of India. Article 39A of the Constitution provides for free legal aid to the deprived and weaker sections of society and to promotes justice on the basis of equal opportunity. In this spirit, the Lega Aid Society organized a Lok Adalat Visit.

The purpose of the visit was to understand the working of court, the nature of duties of the Judicial Officers in the matters of Lok Adalat, to observe how the concept of conciliated settlement of dispute works, General Procedure followed in the Lok Adalat, Jurisdiction of the Lok Adalat and the nature of cases that are referred to the Lok Adalat for settlement.

Students of BA.LL.B & BBA.LL.B (4th and 5th year) and LL.B (2nd and 3rd year) students participated in this Visit Program, learned various Aspects of Lok Adalat and Honble judges enlightened to students on what are the cases come under the Lok Adalat & what is its importance in Present Scenario.
