The results of all three competitions will be declared on the **9th of December, 2023**.

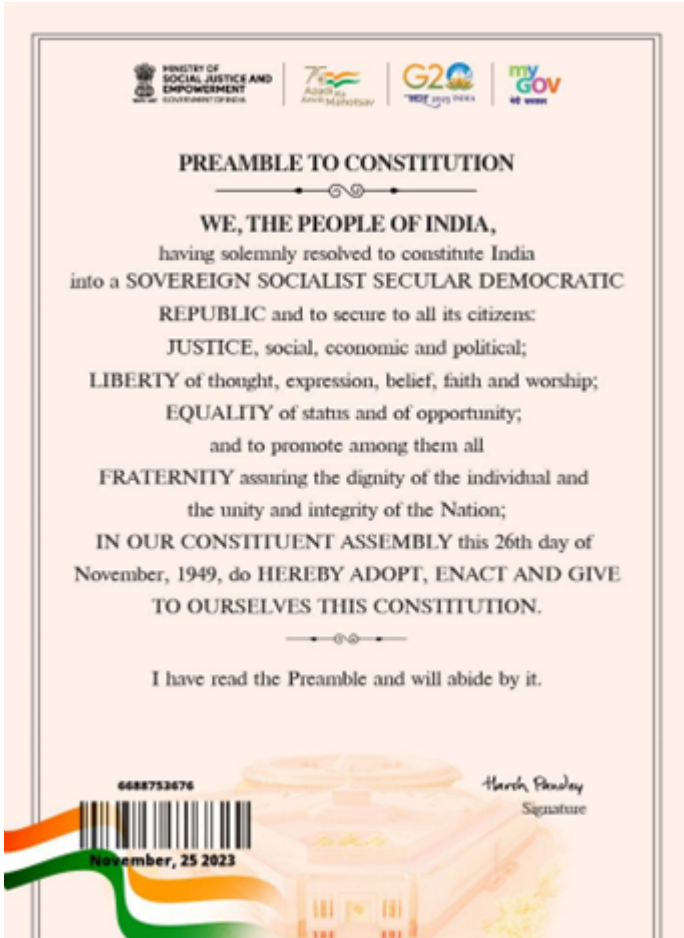
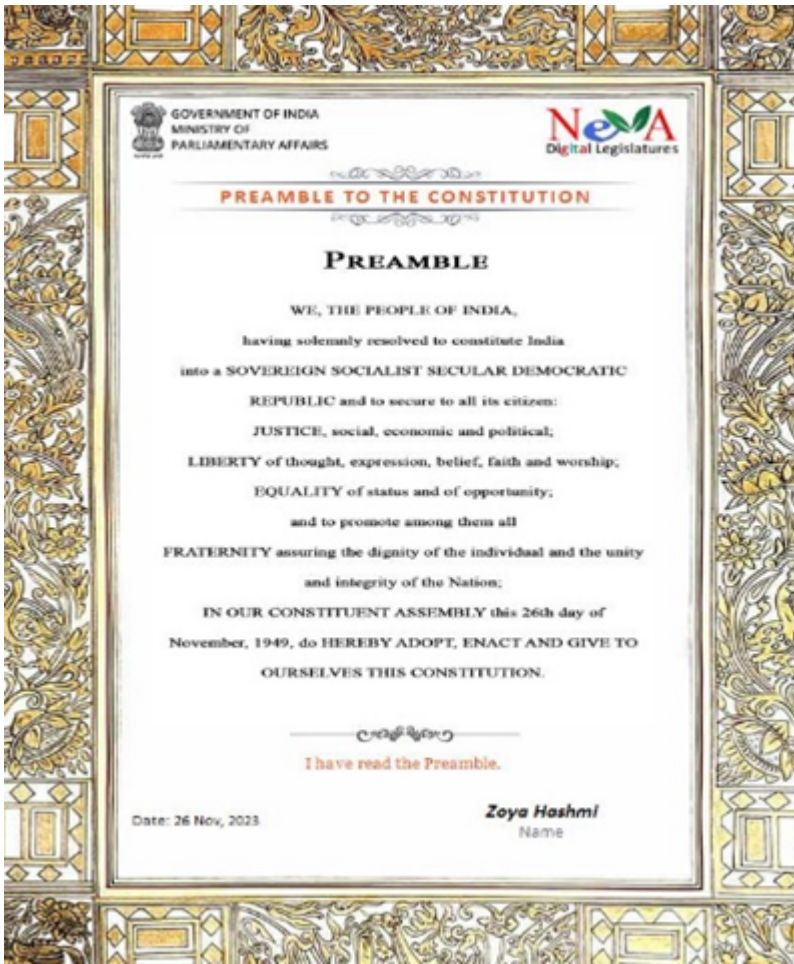
Constitutional Law Society extends gratitude to the Dean & HoD, Faculty of Law, without whose guidance the event would have been incomplete.
