The Legal Aid Society, Faculty of Law, Integral University, is committed to spreading legal awareness and extending free legal assistance to marginalized sections of society, ensuring equitable access to justice. Established in 2019, the society aligns its objectives with Article 39A of the Constitution of India, which mandates the State to provide free legal aid. This initiative aims to fulfil the societal obligation, as outlined in the Legal Services Authorities Act, 1987, or any other applicable law, ensuring access to justice for all citizens. Moreover, the Society actively contributes to the promotion of economic welfare, with a particular focus on vulnerable sections, striving to secure equal justice for all citizens of India. The primary objective is to provide legal representation for those unable to cover fees, ensuring equitable access to justice and fostering a more inclusive legal system.

In line with the founding principles of the society, a Free Legal Aid Camp was organized at **ILM School, village Chetanpurva, tehsil BKT, Dist. Lucknow** on **9th March 2024**. The Free Legal Aid camp centred around the theme "**Nyaya Chala Nirdhan Ke Dwaar**". The event was held under the guidance of **Senior Advocate Ausaf Ahmad Khan** from the **High Court of Judicature at Allahabad, Lucknow Bench** aimed to uphold the ethos of justice for the underprivileged. This initiative underscores our commitment to legal awareness and community engagement, fostering a culture of inclusivity and justice. Prof. (Dr.) Naseem Ahmed, Dean of the Faculty of Law and Dr Seema Siddiqui, Head of the Faculty of Law graced the villagers and school staff with insightful speeches, creating awareness about various Legal Aid Camps and schemes formulated for them. Our Dean, in his insightful speech, shared a profound phrase: "A person must fulfil his duties to obtain and cherish his rights." Ms. Bushra Siddiqui, a student member of the society, warmly welcomed our dignitaries during the Camp, and Mr. Shubhansh Srivastava delivered the vote of thanks.
